

What Initiative 42 Means for Your Schools

Since passage of the Mississippi Adequate Education Program in 1997, only twice has the Mississippi Legislature made good on its promise to adequately fund our children's schools. Passage of Initiative 42 will hold the Legislature accountable for following its own law. **See below the additional funding your district would have received this year and since 2008, the last time schools were fully funded, had the Legislature followed its own school funding law, a requirement that will be phased in if Initiative 42 is passed.**
